MINUTES

Meeting called to order at 6:30 P.M.

Present: Chairman Gerald Picardi, Robert Ogilvie, Associate Member and Health Agent Tara Tradd as Recording Secretary

Office Business:

- Next Board of Health Meeting August 11, 2016 – So Noted.
- Warrant for Approval - Warrants in the amount of \$32,151.20 and \$15,000.58 approved for payment.

Hearings:

- **527 West Main Street, Septic System Repair, George Collins, P.E.**
The proposed plan is to repair a failed septic system serving a four-bedroom single family home with no plans to increase the flows. An above ground pool in the back yard will need to be removed in order to install the leaching field. The system will flow by gravity to a septic tank. Bob Ogilvie moved to approve the three local upgrade approvals as requested, Gerry Picardi, seconded, vote carried unanimously. Robert Ogilvie moved to approve the proposed plan dated July 6, 2016, Gerry Picardi seconded, vote carried unanimously.
- **129 Page Street, Septic System Repair, George Collins, P.E.**
The plan proposes to repair a septic system serving a 4-bedroom dwelling with no plans to increase flows. A Local upgrade variance request from 5' to 4' to groundwater was requested this will allow the system to flow via gravity and help with the final grading. Robert Ogilvie moved to approve the proposed plan dated July 6, 2016, Gerry Picardi seconded, vote carried unanimously.

- **Health Agent's Contract** – there was a brief discussion regarding the language of the Health Agent's contract for the period of July 1, 2016 – June 30, 2019 the Selectmen have some concerns regarding the contract renewal form that the Board of Health entered into with the Health Agent.

New Business:

- **DPW NOTICE** – A brief mention was given to the Board of Health via the cell phone txt messaging system stating that untreated water from Father's Day weekend in June was introduced and delivered to the residents. No test results or reports have been submitted to the Board of Health for explanation or review.
