The CPC reviewed the Capital Improvement Plan FY2021-FY2025. The committee members will review it and come back with any concerns. There are some questions regarding some of the items on the project list that will be further discussed. The CPC discussed the benefit of using grants as much as possible to help with costs.

Meeting Motions/Actions/Summary of Discussions:

Collins Center: David Colton

Online survey went to department heads

\$25,000 Capital Projects

Life Span of 10 years

Eight departments submitted three projects

Does not include public works, the Collins Center is working with them.

The Collins Center organized these projects into a master spreadsheet plus the questionnaire. If eligible for state grants, that will be put into the spreadsheet.

Collins Center went ahead and scored the projects by doing site visits. The following is the methodology they used: Look at 4 main areas (see scoring methodology):

- 1. Does the project align with established plans, goals, laws and regulations?
- 2. What is the public impact of the project?
- 3. How does the project effect/impact finances?
- 4. The project's impact on internal operations?

Collins Center will make a recommendation in their report that an Energy Company come in to audit any piece of equipment that uses energy, called ESCO=Energy Services Contract (it's a private company/does not require you to have to go through the bidding law).

They will come back with a preliminary asset once the department heads have completed their survey. Between preliminary assessment and final report, Collins would come down. The scoring is subjective based on risk and impact. The CPC will have access to the questionnaire. It's a link - have the data which is on survey monkey, and then convert that into a spreadsheet. The questionnaire will have to go out to each department every year. Each of the four main areas needs to get the 50 points. Its' an emergency if you don't have an alternative piece of emergency equipment. Is there an alternative way to provide the service in an emergency? Mr. Enos is talking to DPW, Collins does not have enough information to go on yet, he met with them. The plan has to be put together based on estimated quotes – CPC approved the project/recommend it to town meeting and if it is approved then it goes out for bids.

Finance:

Financial Committee will meet Monday, June 10, 2019 at 7:00 p.m. Finance policies: The final updated draft has been sent to Matt Doucet, he will forward copies to us.
