Chairman Hart announced that pursuant to Governor Baker's March 12, 2020, Order suspending certain provisions of the Opening Meeting Law, G.L. c. 30A, & 18, and the Governor's March 15, 2020, Order imposing a strict limitation of the number of people that may gather in one place, this meeting of the Park and Recreation Board is being conducted via remote participation. No in- person attendance of members of the public was permitted, but every effort was made to ensure that the public can access the proceeding as provided for in the order. Chairman Hart reminded the viewing audience that persons who would like to view the meeting while in progress may do so by joining the Zoom link for the videoconference.

Chairman Hart called the meeting to order at 8:02 p.m. with all members present through the videoconference Zoom. Each Board member acknowledged their presence at the meeting by responding in the affirmative during the roll call.

#### **Minutes**

Vice Chairman Chapman made a motion to approve the minutes from March 9, 2021, March 16, 2021, April 28, 2021, and June 3, 2021 as written. Commissioner Lyons second the motion. A roll call vote was taken. Commissioner Ferro voted aye. Commissioner Lyons voted aye. Vice Chairman Chapman voted aye. Chairman Hart voted aye. The motion carried.

## **Summer Program**

The Board was updated that a previously approved applicant has decided not to take the position of counselor for the 2021 Summer Program. Recreation Director Mayo recommended another applicant for the position.

Vice Chairman Chapman made a motion to recommend Anthony Graziano, at a G10, step 3 at \$13.54 per hour to the Board of Selectman for approval. Commissioner Lyons second the motion. A roll call vote was taken. Commissioner Ferro voted aye. Commissioner Lyons voted aye. Vice Chairman Chapman voted aye. Chairman Hart voted aye. The motion carried.

The Board discussed the fee charged for the Workreation program. The fee of twenty-five dollars will be waived for the 2021 program, due to having no field trips scheduled. Community service hours will still be awarded.

The Recreation Director discussed an updated plan for drop off/pick up for the upcoming program. The drop off/pick up will be a one-way flow of traffic, with parents entering the parking lot from the Page Street entrance and exiting onto Victory Ave. The drop off/pick up area will have signage, cones and staff helping to keep everyone moving and safe. Staff will be available at all entrances/exits to help assist walkers safely to and from the program. Parents will remain in cars in the drop off/pick up line, staff with assist parents/guardians with signing in/out and children getting in/out of the vehicle. A designated spot will be assigned for any parent that has a question to pull over and out of the way of the flow of traffic.

The Recreation Director updated the Board that she has a meeting scheduled on July 15<sup>th</sup> with the Town Administrator and BC Tent to discuss the purchase of a tent. The Recreation Director will also discuss misting tent options at the meeting.
