- Messina has a possible tenant (furniture store) for 75 Stockwell Drive
- Customer looking to buy the old Staples building
- 61 Straffello sold to new ownership. They are looking to complete some interior demolition (take down petitions and walls to open-up the building warehouse to its full potential. The new owners asked about raising the roof which is currently at 22 ft., they want 24ft. There are currently no tenants. They will need sprinkler modifications.
- Residentially there are small jobs taking longer to complete due to lack of product.
