Avon Planning Board - Meeting Minutes

Date: December 18, 2014

Charles Comeau called the meeting of the Planning Board to order at 7:15

• **Public Hearing for 1 Kiddie Drive, Avon**

Mr. Pillarella read the Public Hearing Notice:

Notice is hereby given that the Avon Planning Board will hold a Public Hearing on Thursday, December 18, 2014 at 7:00 P.M. regarding property located at One Kiddie Drive, This hearing will consist of a Special Permit for the use of 40' shipping container for storage at said address. Under Zoning By-Laws Section 7-5 "Specific Requirements for Particular Uses by Special Permit", subsection L. "Trailers Used for Storage" Assessors, Map B6-1-1 The hearing will be held at the Avon Town Hall, Buckley Center.

Petitioners Presentation- Aziz Namrouchi stated that he rents a storage container at 1 Kiddie Drive (Logan Furniture). He has a truck and parks it 10 days a month. He states that the Parking lot is in the back close to the boats. And he rents a container where he parks. His container consists of tools and tires. He is requesting a Special Permit for the use of 40 foot shipping container for storage at 1 Kiddie Drive.

Discussion and Comments- Mr. Comeau asked how long has he been there and if he rents an office? Mr. Namrouchi stated that he has been there for six months and that he did not rent an office but a container for parking his truck. Mr. Comeau stated that the Planning Board grants extra space to a business that have a Special Permit for Seasonal or overflow, usually related to the building.

The Building needs a certain amount of parking spaces. By-Law stipulates that it will allow for storage containers seasonal and temporary. The owner had come in front of the Zoning Board of Appeals around six months ago. The Zoning Board of Appeals decision was that it didn't fit in the intent of the by-law. And at the time was denied a Special Permit. Mr. Pillarella asked if he was parking the truck there. Mr. Namrouchi stated he was. Mr. Pillarella stated that storage trailers on site would have to be associated with building operations. If you rented office space and the building warehouse space was full, then possibly temporary storage could be sought. If office space was rented or leased to tenant, then interior warehouse space should be made available.

Mr. Namrouchi respectfully asked if the Planning Board could grant him to the end of December to relocate. Mr. Comeau stated if the Petitioner needed to the end of January 2015, that it would be ok with the Board.

- A motion was made by Mr Pillarella to Deny a Special Permit for a storage trailer, and to direct the Building Inspector that the Petitioner has till the end of January 2015 to relocate. Seconded by Jason Suzor, All in favor.

Continuance for 407 Page Street- A request was made by the applicant by e-mail as follows: RE: Site Plan public hearing for Feldman #407 Page Street.

The applicant is requesting a continuance for the December 18th 2014 continued Site Plan public hearing for the property located at 407 Page St. Avon. A motion was made by Mr. Pillarella to approve the minutes for October 23, 2014, seconded by Jay Suzor All in Favor


