With the permission of the BOR, Mr. Gladstone asked to speak stating the MGL cited in the statute of limitations ran out and it was too late for the BOR to act upon. Mr. Gladstone stated the letter should have been received four days prior to the town meeting, May 2, 2023. Mr. Riley, KP Law, disagreed with Mr. Gladstone. A motion was made by Mr. Mooney, seconded by Ms. Beckerman, to move forward with a residency public hearing. A roll call vote was taken. Mr. Mooney voted aye; Ms. Beckerman voted aye; Mr. Lawler voted aye; Ms. Bessette voted aye; Motion carried. The BOR's discussed dates and times for the hearing. A motion was made by Mr. Mooney and seconded by Ms. Beckerman to conduct the public hearing on Wednesday, May 17th at 2:00pm. A roll call vote was taken. Mr. Mooney voted aye; Ms. Beckerman voted aye; Mr. Lawler voted aye; Ms. Bessette voted aye. Motion carried.

Mr. Mooney encourages anyone with information to forward to the Town Clerk's office or to send a written statement.
