SPRING HOURS FOR THE COMPOST SITE

The Compost Site will have extended hours of operation for the spring and summer months! As of April 2, 2022, the Compost Site will be open on Saturdays, Sundays, and Wednesdays from 9:00 a.m. to 2:00 p.m. The Compost Site is located at 100 Wales Avenue. Identification must be shown. The site offers many ways for residents to dispose of items. There is now a cardboard dumpster, a metal dumpster, an electronics dumpster, a place to recycle mattresses/box springs, and a place to dispose of all mercury containing items. Below is a list of commonly disposed of items at the Compost Site. The next Bulk Collection Day will be on May 21, 2022. A limit of five (5) items may be placed out for bulk collection. All tickets for items with fees must be purchased at Avon Town Hall prior to disposal.

Grass Clippings Leaves, Brush	Less than 6" diameter	No Fee
Electronics	fax machines, stereos, radio equipment, propane tanks, cable attachments, e-book readers, scanners, wire, speakers, metal (non-ferrous), cell phones, telephone, tablets, printers, keyboard, computer mice, telecommunications equipment, VCR/DVD players, space heaters, servers, copiers, cameras, modems.	No Fee
Electronics	TV's, computers, monitors, laptops, microwaves, air conditioners (no commercial units)	\$10.00 Fee
Appliances	Refrigerators (must have doors removed), stove, dishwasher, washers, dryers, humidifiers, dehumidifiers, water heaters	\$32.00 Fee for Disposal at Composite Site (Free for quarterly bulk collection)
Mercury Containing Items	fluorescent lights, mercury items (thermometers, thermostats, batteries)	No Fee
Cardboard	Any cardboard must be flattened	No Fee
Batteries	most single-use household batteries (AAA, AA, C, D and 9 volt), alkaline batteries, batteries that contain NO mercury	No Fee
Furniture	couches, dressers, chairs, and other small items	\$32.00 Fee for Disposal at Composite Site (Free for quarterly bulk collection)
Mattresses and Box Springs	Acceptable: Twin, double, queen, king, California king; traditional mattresses/box springs constructed of metal, textiles, wood, and foam. Crib mattresses and memory foam mattresses. Unacceptable: Excessively torn, punctured, soiled or moldy items. Twisted or crushed mattresses or broken box springs. Wet or frozen mattresses or box springs. Mattresses or box springs infested with bed bugs or other pests. Futons, fold-out sofa beds. Mattress pads and toppers. Infant sleeping pads; air or water beds; any other furniture or textiles.	If unacceptable and cannot be recycled, there is a fee of \$60 to dispose of each item.

EMPLOYMENT OPPORTUNITIES

The Town of Avon is hiring the following positions:

Town Accountant - The Town Accountant, under the direction of the Town Administrator, is responsible for day-to-day activities of the town's accounting function as to maintenance of all financial records, accounts payable, internal, and external audit, compliance with applicable State laws and town policies, and maintenance of the Town's accounting system. The job requires thorough knowledge of municipal accounting laws, regulations, policies, and procedures as well as, extensive knowledge of GAAP, UMAS, and GASB regulations. Applicant must have a minimum of a bachelor's degree in accounting, business, finance, or related field, with 5 to 7 years of related work experience; and at least 2 years in a municipal setting.

Council on Aging Volunteers & Activities Coordinator – The Town of Avon is seeking a part-time Volunteer & Activities Coordinator to provide support and supervision to the (COA) volunteers while enhancing program delivery and services to Avon's senior citizens, customer service to the public, and to support the office functions of staff members. Bachelor's Degree is preferred in Human Services or related field. Must have two to three (2-3) years of experience in the human service field; experience with the elderly preferred; or any equivalent and relevant combination of education, experience, and training. Must be willing to be CPR Certified. Possession of a valid motor vehicle operator's license.

Public Safety Dispatcher – This is a part-time, AFSCME union position of Public Safety Dispatcher to receive and process emergency and non-emergency signals and calls for service. Dispatch police, fire, EMS and other emergency units and personnel as needed. Monitor and operate emergency signaling, radio, computer, telephone, alarm, and other specialized equipment in support of public safety communications and dispatch functions. Requirements include a high school diploma/GED, college degree desirable. Must achieve within the first 3 months of employment, or as soon as reasonable, based upon the availability of courses; CPR certification, CJIS operator certification and EMD certification. Work schedule includes a rotating shift between the hours of 12 AM - 8 AM, however hours /shifts are subject to change based upon needs of the agency. May be required to work rotating or fixed shifts on nights, holidays, and weekends.

Firefighter/Paramedic – The Town of Avon is accepting applications for a vacancy in the Avon Fire Department for the position of full-time Firefighter / Paramedic. The successful candidate will work rotating 24-hour shifts that will result in an average 42-hour work week over an eight-week cycle. Applicants must possess a High School diploma, a valid Massachusetts Driver's License, and a valid Massachusetts Emergency Medical Technician's Certification.

FAREWELL CAPTAIN KEVIN J. FOSTER

Foster Day in the Town of Avon. Senator Timilty issued Captain Foster a Citation on behalf of the Senate. Chief Spurr gave Captain Foster a refurbished fire alarm system as a commemorative gift.
