Review of Articles on the Warrant for Special Town Meeting

Selectman Brady called the meeting to order at 6:00 p.m. Chairman Rose was late to the meeting. Mr. Brady asked the Town Administrator for an update on amended Articles due to monetary changes. Mr. Enos stated that Article Four has been amended for more specific wording as to what repairs are needed at the Butler Elementary School. However, the amount of money requested has not changed. Mr. Enos stated that Article Seven pertaining to the Police settlement with the Joint Labor Management Committee has been raised from \$250,000 to \$300,000 to incorporate the recently signed Memorandum of Agreement for a 2% wage increase for the Police Officers from July 1, 2017 through June 30, 2018. Mr. Enos informed the Board that Article 13 regarding the purchase of the property at 144-156 South Street has decreased from \$350,000 to \$300,000. Mr. Beckerman noted that these changes would not impact the total amount of funding the Town is asking the residents to vote for at the Special Town Meeting.

Adjournment

At 6:35 p.m., Mr. Beckerman made a motion for the Board to enter into Executive Session to discuss an Employment Agreement with Non-Union Personnel. Mr. Brady seconded the motion. The motion carried. The Board would reconvene in Open Session upon the conclusion of the Executive Session.
