# **Notice of Intent**

15 Overlook Dr., Avon, MA – Mr. Lyons presents engineering recommendation to the Commission. 15 Overlook Dr., is a failed septic system. The proposed leaching field is as close as 33' from wetlands. Erosion control as close as 15' to accommodate proposed leaching field, septic tanks, and grading work. Erosion control wraps the entire project.

Motion to accept the proposed recommendation by Mr. Canducci, second by Chair Garcia, Mr. Mekjain abstains (abutter to property.) Roll Call – Mr. Canducci, yes; Chair Garcia, yes. Motion is affirmative with 2 members voting yes and 1 abstention.

73 North Main St., Avon, MA – Mr. Lyons presents engineering recommendation to the Commission. This is a proposed pipe and stone installation, gravity-based system to replace current septic system. Erosion control wraps the entire project.

Motion to accept the proposed recommendation by Mr. Canducci, seconded by Mr. Mekjain. Roll Call vote Mr. Canducci, yes; Mr. Mekjain, yes; Chair Garcia, yes. Motion is affirmative with 3 members voting.
