

ARCHITECTURAL DESCRIPTION:

Describe architectural features. Evaluate the characteristics of this building in terms of other buildings within the community.

Located on a sloping site amid glacial outcroppings, the house is oriented to the east and perpendicular to the street. An uncutstone retaining wall lines the street frontage. An asphalt-paved driveway leads past the façade to a parking area at the north
end of the house. The frame house rests on a cut stone foundation and rises two stories to a side-gabled roof with overhanging
eaves and gable-end cornice returns. Two interior brick chimneys with corbeled caps are located atop the roof ridge. The
house is five bays wide and two bays deep with a single window in the gable peak. The center entrance contains a paneled
wood door framed by full-height sidelights. The entablature features a shallow pointed-arch crown. The house is clad with wood
clapboards and trimmed with cornerboards and a frieze. Windows are 2/2 wood sash with external storm windows. The flat
window surrounds feature a slender drip cap. The house retains a high level of integrity.

HISTORICAL NARRATIVE

24 Rock Street was likely constructed circa 1860-1865 for Orrin and Sarah Thayer. Stoughton native Orrin Tracey Thayer (1826-1875)¹ married his wife, Sarah Packard Thayer (1832-1906) (known as Sally), in 1852. Orrin Thayer served in the Union Army, Company A, 33rd Massachusetts Infantry. The Thayer family first appears in Stoughton census records in 1865. At that time, Orrin Thayer was working as a "pedlar." The 1870 census recorded his occupation as "huckster." (Historically, peddlers were persons who traveled to sell items, whereas, a huckster sold items from a fixed location, such as a stall.) Orrin and Sally's son, Charles Emery Thayer (1857-1930)² and his wife, Lillian J. Hamilton Thayer (1866-1946),³ were married in 1882 and made this their residence. Charles Thayer worked as a boot maker and as a wholesale produce dealer.

In 1888, Edward Doherty purchased the house.⁴ At the time, Doherty owned 30 Rock Street next door. Census records indicate that, during the late 19th and early 20th centuries, three of the four houses on Rock Street were occupied by members of the extended Doherty family. Nearly all of the Doherty men on Rock Street were employed in the shoe manufacturing industry. The property remained in the Doherty family until 1940.⁵
