### **ARCHITECTURAL DESCRIPTION:**

Describe architectural features. Evaluate the characteristics of this building in terms of other buildings within the community.

Located on a sloping lot, the house is oriented to the west, toward the street. A narrow lawn separates the house from the roadway. The 1-story frame house rests on a banked brick foundation and is capped with a side-gabled roof. The roof has a shallow overhang on the east and west elevations and no overhang on the side elevations. An interior brick chimney is located at the north and south ends of the roof ridge. The house is covered with wood clapboards and trimmed with cornerboards, a frieze, and gable-end cornice returns. The 5-bay façade has a center entrance framed by a pilastered surround. The paneled wood door contains two vertical panels below 8 small lights. Windows are 2/2 wood sash with flat surrounds and backband trim. The side elevations are two bays deep with two windows in the gable peak. One window at the east end of the south elevation has been replaced with a metal-frame casement. The raised foundation is exposed on the south elevation and contains two tall 2/2 wood sash windows and a multi-light door. A small 1-story ell is attached to the north end of the rear elevation.

The house is a good example of vernacular Greek Revival architecture in Avon. The building retains a high level of integrity.

#### HISTORICAL NARRATIVE

Discuss the history of the building. Explain its associations with local (or state) history. Include uses of the building, and the role(s) the owners/occupants played within the community.

404 West Main Street was likely constructed circa 1847, the year in which John Lynch purchased this lot of land.<sup>1</sup> John Lynch (1813-1887)<sup>2</sup> and his wife, Margaret (1808-1892) were both born in Ireland and lived here with their nine children. John Lynch worked in a boot and shoe factory, as did his sons and one his daughters, as they became teenagers. The Lynch home was part of the "Donegal" area of East Stoughton, so named for the numerous Irish immigrants who settled along West Main Street between Pond Street and Harrison Boulevard. Irish immigrants began arriving in greater numbers to East Stoughton in the 1840s and 1850s. The Irish immigrants "took jobs as day laborers on farms, and later they worked in large numbers in shoe factories."<sup>3</sup> John and Margaret Lynch's children, Cornelius Lynch and Mary Lynch Geary, inherited the house after their father's death.<sup>4</sup> The property remained in the Lynch-Geary family until 1978.<sup>5</sup>
