Minutes

Commissioner Lyons made a motion to accept the minutes of April 6, 2022 as written. Vice Chairman Chapman second the motion. Vice Chairman Chapman voted aye. Commissioner Lyons voted aye. Chairman Hart voted aye. The motion carried.

Miller Tracy mural/playground

Chairman Hart updated the Board on work completed by DPW, including new signs and repairs to the chain link fence.

The Board discussed replacing the gate on the inside entrance to the playground area. The discussion was tabled until after the playground inspections have been completed.

Spring planning

Recreation Director Mayo provided the Board with a recap on past events and an update for upcoming events.

Recreation Director Mayo updated the Board that only 1 porta potty was rented. The Athletic Director from AMHS will not need a porta potty at Noonan field, access to the school will be allowed.

Department Head meeting update

Recreation Director Mayo updated the Board that a Commissioner will need to be available to speak on our article at the Annual Town Meeting, if needed. Recreation Director Mayo will ask if a meeting will need to be posted if we have a quorum present.

May 14th will be the Board of Health's town clean-up day.

Summer Program

The Board discussed removing the Covid waiver from our online registration, Recreation Director Mayo informed the Board that the waiver is no longer required by the Board of Health. Recreation Director Mayo will add our previous language on sick and behavior guidelines to the online registration.

The Board discussed how the online payment center will work for field trips this summer with the requirement that families must be registered for the program to participate on field trips. Recreation Director Mayo will reach out to Unipay to ask how the payment center will be set up.

Summer staff positions will be available after the pay rates are finalized at the next Board of Selectmen meeting. Recreation Director Mayo with work with Shanna Faro to get the job postings up.

The Board discussed the possible change to all town revolving accounts after the Annual Town Meeting.
