Chairman Comeau announced that pursuant to Governor Baker's March 12, 2020 Order Suspending Certain Provisions of the Open Meeting Law, G.L. c. 30A, Subchapter 20 and the Governor's March 23, 2020 Order imposing limitations on the number of people that may gather in one place, this hearing of the Avon Planning Board will be conducted via remote participation. No in-person attendance of members of the public was permitted, but every effort was made to ensure that the public can adequately access the proceedings as provided for in the Order. Chairman Comeau reminded the viewing audience that persons who would like to view this meeting while in progress may do so by joining the Zoom link for the video conference in session.

Chuck Comeau, Chair called the meeting to order at 7:02 p.m. with all members present. Each Board member acknowledged their presence at the meeting by responding in the affirmative during the roll call.

Minutes

The Planning Board received a Letter for a Cease and desist for 23 East High Street, Avon Zoning bylaw section 255 5.3 A13 prohibits the parking of commercial vehicles of a gross weight in excess of 5,000 pounds in any residential zone without a special permit. The owner has a month to remove the vehicles. Mr. Bob Pillarella stated that the vehicles have been removed. Mr. Borden discussed other options regarding the parking of these vehicles with the owner.

Building Inspector update

- Messina indicated that they are making more of an effort to rent out their property
- Ashley Furniture is looking at space at 75 Stockwell Drive and the vacant space
- There is a possibility of both vacant spaces at 1 Harrison being rented. There are tenants currently looking at these properties.
- Lowe's Outlet located on Stockwell Drive, Unit 1 is possibly opening on
- The Certificate of Inspection was completed for all of Jordan's Furniture amusement facilities with the exception of the slide.
- The construction of the Fire station is moving along.
