Notice is hereby given that the Avon Planning Board will hold a Public Hearing on **Thursday, April 21, 2016 at 7:30 P.M.** For potential Zoning By-Law change related to creating an overlay district at 257-299 Pond Street and Bodwell Street intersection, make changes to Avon Zoning By-Law section 2-definitions, and review extensions or renewals of Special Permits issued by the Special Permit Granting Authority. The hearing will be held in the Avon Planning Board Office at the Avon Town Hall, Buckley Center.

(A) The Planning Board held a Public Hearing on April 21, 2016. Advertised as required. After discussion, the Planning Board voted unanimously to Amend the Boundaries of the Water Supply Protection Zoning District to Meet the Requirements of Massachusetts Department Regulation 310 CMR 22, 21, Ground Water Supply Protection.
