The Avon Public Safety Building Committee met at Town Hall on Wednesday evening, February 25th, 2015, at 6:30 p.m.

The meeting was called to order at 6:35 p.m. by Tracy Self. She said the meeting for the night was going to be two-fold:

- 1.) Approve the Meeting Minutes of January 6^{th} , January 8^{th} and January 21^{st} , 2015.
- 2.) Discuss the upcoming Coffee Hour to be held on Saturday, February 28th, 2015.

Tracy asked the Committee if anyone had any questions or comments on any of the Meeting Minutes she had sent out. There weren't any so she asked for someone to make a motion to approve the Minutes as read. Carl Fischer made the motion to approve the three Meeting Minutes and Jason Suzor seconded the motion. The Committee voted unanimously to approve them as read.

Tracy then asked Alex Sinclair to talk about Walpole and Sharon regarding their new facilities. He said Walpole had not passed their ballot vote. Tracy mentioned to the Committee that she had talked to Jeff McElravy regarding costs to maintain the facility, Jeff put her in touch with some towns with the same size buildings for discussion. Budgets were next discussed.

At this time Tracy brought up the item on the agenda, the Coffee Hour to be held on Saturday and what potential questions the townspeople might have for them.

- ✓ Have Bruce Lane put the March 12th Coffee Hour on cable
- ✓ The Agenda for the Coffee Hour will be:
 - > Introduction of the Committee
 - > 15 Minute PowerPoint Presentation
 - Question and Answer Period
 - Mention that every place possible has been looked at
 - No relocation costs
 - The conceptual drawings are not finalized
 - ❖ They will do the Police building first and the Fire second
 - The first year will be for designing the buildings, and then they will deal with permits, conservation, etc.
 - Not having the two departments together will save money
