The applicant further agrees that before final approval of the definitive plan, the applicant will cause to be filed with the Board a bond in form satisfactory to the Board, conditioned on the completion of all required work on the ground in the time and manner prescribed, in a penal sum sufficient, in the opinion of the Board, to cover the cost of such work, and executed by the applicant as principal and an indemnity or surety company authorized to do business in the Commonwealth and satisfactory to the Board as surety, or secured by the deposit with the Town Treasurer-Collector of cash or United States Government bonds in an amount equal to the penal sum of the bond.
- 9b. The applicant requests the Board to approve the definitive plan on condition that no lot in the subdivision shall be sold and no building shall be erected or placed on any lot until the required work on the ground necessary to adequately serve such lot has been completed to the satisfaction of the Board.
- 10. This application is accompanied by an original drawing of the proposed definitive plan, a designer's certificate, and approved cost estimates for all work to be covered by bond.
