MINUTES BOARD OF REGISTRARS Monday, April 24, 2023

- Others Present: Charles Marinelli, Paul Garcia, Brian Riley, KP Law (Remote), Sharon Simon (Remote)


A motion was made by Mr. Mooney and seconded by Mr. Lawler to approve the minutes from March 30, 2023. A roll call vote was taken. Mr. Mooney voted aye; Ms. Bessette voted aye; Ms. Tallent voted aye; Mr. Lawler voted aye. Motion carried.

This meeting of the BOR was called after the Town Clerk's office received a Recount Petition on April 20, 2023, from Charles Marinelli. Ms. Bessette read the signer's statement; fifteen signatures were certified. The petition was passed around for the signatures of the BOR. The BOR's discussed dates and times for the recount. A motion was made by Mr. Mooney and seconded by Mr. Lawler to conduct the recount on Wednesday, May 3rd at 6:30pm. Ballots will be delivered at 6pm for blocking and the recount will begin at 6:30pm. A roll call vote was taken. Mr. Mooney voted aye; Ms. Bessette voted aye; Ms. Tallent voted aye; Mr. Lawler voted aye. Motion carried.

Mr. Brian Riley, KP Law explained the process. No one had any questions. Ms. Bessette will prepare the letter to be delivered to the two parties on Tuesday, April 25th. Ms. Bessette will schedule the appropriate number of workers and prepare all recount material.
